Post-emergent herbicides	0.3 - 1.0 litres	Swan 704 Penetrating Spray Adjuvant may be used in place of non-ionic surfactants or crop oils. Subject to spray volumes, usage rates may vary between 0.2 - 2.0 litres of Swan 704 Penetrating Spray Adjuvant per hectare.

GENERAL INSTRUCTIONS

Swan 704 Penetrating Spray Adjuvant is a highly penetrating spray adjuvant suitable for use with certain post emergent herbicides. It improves herbicide performance by utilising the excellent penetration effect of esterified vegetable oils in combination with the wetting and spreading characteristics of non-ionic surfactants.

Swan 704 Penetrating Spray Adjuvant can be added to certain post emergent herbicides to increase efficiency. In some situations, Swan 704 Penetrating Spray Adjuvant may reduce selectivity. Care must be exercised when applying Swan 704 Penetrating Spray Adjuvant with post emergent herbicides on sensitive crops under conditions where plants are subject to drought stress, high temperatures, and high humidity. If in doubt use precaution and trial by application to a small area before committing to a large-scale application.

Mixing and Spraying

Follow directions on the herbicide label. Half fill spray tank with water and add the required amount of herbicide while agitating. Top up the tank with water then add the required amount of Swan 704 Penetrating Spray Adjuvant and continue agitating while spraying.

PRECAUTIONS

Read all directions for use on the Swan 704 Penetrating Spray Adjuvant label and on the herbicide label. The herbicide manufacturer's directions and recommendations always take precedence over directions contained on the label.

PROTECTION OF WILDLIFE, FISH, CRUSTACEA, AND ENVIRONMENT

DO NOT contaminate streams, rivers or watercourses with the chemical or used containers.

STORAGE AND DISPOSAL

KEEP OUT OF REACH OF CHILDREN.

Store in the closed original container, in a well-ventilated area as cool as possible. Protect from frost. DO NOT store for prolonged periods in direct sunlight. Under conditions below 0°C, Swan 704 Penetrating Spray Adjuvant may thicken and become cloudy. It returns to a normal clear liquid state above 0°C.

Triple-rinse containers before disposal. Add rinsings to spray tank. DO NOT dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recyclers or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging for appropriate disposal to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose clear of waterways, desirable vegetation, and tree roots, in compliance with relevant Local, State or Territory government regulations. DO NOT burn empty containers or product.

SAFETY DIRECTIONS

May irritate the eyes and skin. Avoid contact with skin or eyes. Avoid inhaling vapour or spray mist. When opening the container and preparing the spray, wear overalls, rubber gloves and goggles or disposable spray shield. After each day's use wash contaminated clothing, gloves and face shield or goggles with soap and water.
